To provide as much information in a timely manner, USA Lacrosse is releasing this Preliminary Notice to the Athlete Selection Procedures for the 2028 Olympic Summer Games (Games). This document is being written as a complement, and not a substitute to the 2028 Olympic Summer Games Athlete Selection Procedures. Additional communication will be released by USA Lacrosse once the Athlete Selection Procedures have been approved by the USOPC.

### **ANTICIPATED ATHLETE ELIGIBILITY CRITERIA**

- Athletes must comply with all World Lacrosse eligibility requirements which will be posted here once available: <https://www.olympics.com/ioc/documents/olympic-games/los-angeles-2028-olympic-games>
- Athletes must be a national of the United States and hold a valid U.S. passport that will not expire for six months after the conclusion of the Games.
- Athletes must adhere to all NGB, USADA, USOPC, WADA, IF and International Olympic Committee (IOC) anti-doping protocols, policies, and procedures including participation in Out-of-Competition Testing, if applicable.
- Athletes must comply with the [USOPC Background Check Policy](#) and [USOPC Athlete Safety Policy](#).

### **WORLD LACROSSE QUALIFICATION SYSTEM OVERVIEW**

- The Los Angeles 2028 Olympic Games Qualification Systems Manual for Lacrosse has not been published by World Lacrosse. The total number of countries will be six Women's teams and six Men's teams, each with a roster of 11 athletes.

## ANTICIPATED EVALUATION EVENT

It is intended that athletes being considered for nomination to the Los Angeles 2028 Olympic Games will be evaluated on their performance at any of the below listed events.

DATE(S)	DESCRIPTION/EVENT NAME
2026 – 2028	Sixes National Team training camps
2026 – 2028	Sixes National Team international events including friendly matches and official matches (e.g., World Lacrosse sanctioned events, Continental qualifiers, World Lacrosse World Championship).
2026 – 2028	Field/Box National Team training camps and international events including friendly matches and official matches (e.g., World Lacrosse sanctioned events, Continental qualifiers, World Lacrosse World Championship).
2026 – 2028	Game performance in all women's and men's professional lacrosse leagues (regular & post season)
2026 – 2028	Game performance in NCAA (regular & post season)

Once selection procedures for the competitions listed above are complete, they will be posted on the USA Lacrosse website ([www.usalacrosse.com](http://www.usalacrosse.com)).

Please note that approval of the USA Lacrosse Athlete Selection Procedures for the 2028 Olympic Summer Games is also contingent on USA Lacrosse being officially certified by the USOPC as the National Governing Body for Lacrosse.
